

BCT Schedule of fixed price offers

Table 2 presents the BCT's fixed price offers for eligible local government areas located wholly or partly within the Western Division of NSW. The BCT has set higher prices for conservation areas of less than 5,000 hectares to recognise the higher conservation management costs per hectare for relatively smaller sites in this part of NSW.

This schedule of fixed price offers is subject to periodic review and the BCT Board may consider changing these prices in the future based on a range of factors, including implementation outcomes and other market information.

Fixed price offers focus on the highest priority NSW Landscapes within biogeographic subregions that are least protected within NSW. The BCT is also focusing on threatened ecological communities and important wetlands in eligible areas across NSW.

The BCT commissions land valuation research to identify average market values for land in each local government area.

The BCT determines a price to serve as a reasonable contribution to conservation management costs based on those land valuations and the land capability classes.
