#### **PRIVACY NOTICE**

The Biodiversity Conservation Trust of NSW (BCT or we/us) is subject to the *Privacy and Personal Information Protection Act 1998* (Privacy Act) in managing your personal information. We are committed to protecting your privacy.

If you sell credits to the BCT then information on the credit transfer will be recorded in the public register held by DPIE in accordance with Part 9 of the *Biodiversity Conservation Act 2016*.

We will not otherwise publish or disclose your personal information to any other person unless you have provided consent, or we are permitted or required to do so under law.

There is no legal requirement for you to provide us with personal information. However, if you do not provide all required information requested, we may not be able to consider your application.

Your personal information will be stored in a secured database.
